#### Please note that there are two parts to this application process.

Part 1 - Fill the application form and Submit online; Part 2 – Email all the mandatory documents.

#### Part 1 - Fill the application form and Submit online

- a) The email ID mentioned in the application form will be used for all correspondences. Please take care to fill in the correct emailID.
- b) Select streams relevant to your area of studies only.
- c) Students are requested to fill in the application form and respond to all the mandatory questions in the form.
- d) Only one application should be sent by a student. In case multiple applications are received, we will treat all as void.
- e) Navigate to the subsequent sections of the application form by clicking on the "Next" button.
- f) Once the application form is completely filled, click on the "Submit" button. You will see an acknowledgement message on the screen along with instructions on how to send the mandatory documents (mentioned in Part 2) in a single email to igpadmin@tatatrusts.org.

Part 2 – Email all the mandatory documents.

- i. Attested clear copies of mark sheets relevant to the academic year 2019-2020. If the mark sheet has not been received, submit a letter from the college specifying the last date of the announcement of the result as per the specimen given (**Annexure A**). Please note student will be liable to submit the marksheet on or before the date specified by the college.
- ii. Current year's fee receipt(s) for the academic year 2020-2021. (If partial or no fee has been paid by the candidate submit a college/ institute letter as per **Annexure B**. Please note, it is mandatory to submit the fee receipt of the paid amount)
- iii. A cancelled cheque OR a first page of the bank passbook pertaining to the student's bank account only.
- iv. Latest Annual Income Proof of parents/ guidance.
- v. Additional 3 more mandatory documents for Masters (MD, MS, MCH, DM, MDS, MPT, Homeopathy 2<sup>nd</sup> & 3<sup>rd</sup> year students only)
  - a. Resume
  - b. Statement of Purpose
  - c. Amount of Stipend received by the student every month (get it on the letter head of the college as per the specimen given (Annexure C)
  - The subject of the email should be "<<Stream Name>>-<<Student Name>>" (E.g. (Masters MCH)-(Swati Suresh Sharma)
  - Kindly note that applications will not be considered for further processing if documents are not sent within 24 hours of submitting the application form.
  - All attached documents should only be in **PDF format**.
  - The documents must be appropriately named (e.g. StudentName-MarksheetSem1.pdf, StudentName-MarksheetSem2.pdf, StudentName-IncomeProofAmit.pdf, StudentName-IncomeProofAnju.pdf, StudentName-FeeReceipt.pdf, StudentName-BankCheque.pdf etc.)
  - Multiple emails with documents for a single application will be ignored.
- b) No clarification will be sought after submission of the form and the documents.
- c) Documents received after due date will **strictly not be considered**.

#### GENERAL INSTRUCTIONS:

- 1. Read the form carefully and understand the instructions clearly before you start filling.
- **2.** Those whose results are not announced for the academic year 2019-2020 are required to get a letter as per the specimen given (**Annexure A**).
- **3.** Those who have not paid the fees or have paid partial fees are requested to get a letter from the college as per the specimen given (**Annexure B**).
- **4.** Masters students receiving stipend are requested to get a letter as per the specimen given (Annexure C)
- **5.** This scholarship partially covers tuition fees and other related academic fees.
- **6.** Students whose fees are covered by stipend or any other institute/ organizations are not eligible to apply.
- **7.** Shortlisted Master's candidates may be called for an interview through Skype. (Please create a Skype id, if you do not have one).
- **8.** Submit only requested documents. Unclear/ illegible/ manipulated documents will not be accepted and the application will be treated as void.
- **9.** Please ensure that bank details (Account Number, Beneficiary name and IFSC) are correctly mentioned. The Trusts' office will not be responsible for a failed transaction due to incorrect information and the correct bank details will not be called for (if sanctioned).
- **10.** The decision of the Trusts on the award of scholarships will be final and communicated through email. Correspondence in this regard will not be entertained.
